Overview

What is the customs duty rate in Oman?

Oman imposes a standard customs duty rate of 5% on the CIF value (Cost, Insurance, and Freight) for most types of cargo, excluding specific goods like liquor, tobacco, and others, which have different rates. Customs duty is an essential part of the import process, ensuring that the government collects revenue while regulating the flow of goods.

What is Oman's tariff schedule?

Oman's tariff schedule imposes duties, generally not exceeding 10 percent, on all foreign, non-American/GCC goods imports. Virtually all U.S.-origin products enjoy duty-free access, and Oman has phased out nearly all tariffs on the remaining handful of products.

Does Oman pay VAT on imports?

In addition to customs duty, imports into Oman are subject to VAT (Value Added Tax). Introduced as part of Oman's broader fiscal reforms, VAT is set at 5% and applies to the CIF value plus the customs duty. This means that the VAT on imports is effectively 5.25% of the CIF value.

Does Oman have a Value-Added Tax?

Oman implements a 5 percent value-added tax (VAT) on most goods and services, consistent with the GCC Unified Agreement. Companies can request advance rulings based on tariff classification, customs valuation, or rules of origin through this [ROP Customs link](#).

What is the VAT rate in Oman?

Introduced as part of Oman's broader fiscal reforms, VAT is set at 5% and applies to the CIF value plus the customs duty. This means that the VAT on imports is effectively 5.25% of the CIF value. VAT Calculation.

Can US companies import bonded goods to Oman?

Despite the entry into force of the U.S.-Oman Free Trade Agreement (FTA) in 2009, U.S. firms report some difficulty importing some goods duty free. The Royal Oman Police Directorate General of Customs (ROP Customs) still occasionally collects customs duties on some bonded items transshipped to Oman by road via the UAE.

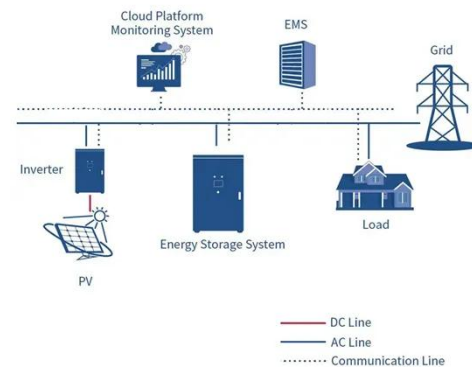

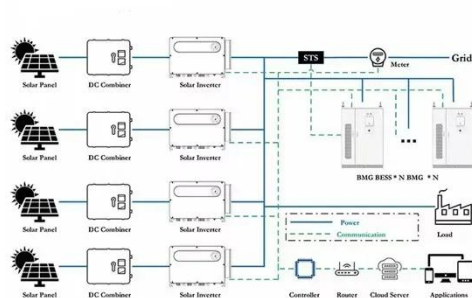

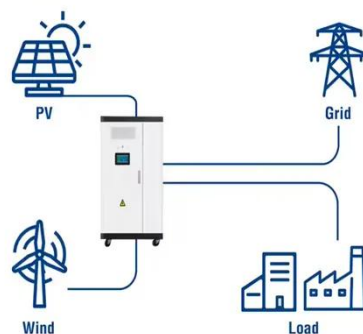
